

# NEWCASTLE INNER CITY BYPASS: RANKIN PARK TO JESMOND (SSI-6888) ENVIRONMENTAL REPRESENTATIVE MONTHLY REPORT September 2023

Reporting Period: 1 to 30 September 2023

This Environmental Representative (ER) Monthly Report is prepared in accordance with the Minister's Condition of Approval A26(k) for the Newcastle Inner City Bypass: Rankin Park to Jesmond (SSI-6888) and is consistent with the Environmental Representative Protocol (October 2018).

#### **PROJECT SUMMARY**

Delivery of a 3.4km section of the Newcastle Inner City Bypass (NICB) which will be built between Rankin Park to Jesmond (RP2J) and to the west of the John Hunter Hospital.

The Rankin Park to Jesmond project is the fifth section of the NICB, which forms part of the Transport for NSW long term strategy to connect the Pacific Highway between Bennetts Green and Sandgate.

The project has been broken into four stages:

- Stage 1: Detailed design investigations (geotechnical and utility investigations) and low impact works (house demolition, heritage investigations, at-house noise treatment works, access, installation of environmental controls).
- Stage 2: Shared Path Bridge.
- Stage 3: Southern Interchange Utilities relocation works.
- Stage 4: Main RP2J road construction.

#### PROJECT WORKS SUMMARY

- Stage 1: Low Impact Works including, House Demolition which was completed June 2021.
- Stage 2: Shared Path Bridge was completed March 2021.
- Stage 3: Southern Interchange Utility Relocation works were completed in August 2022.
- Stage 4: Main construction works underway, commenced March 2023.
  At House Noise Treatment (AHNT) consultation and implementation commenced March 2022.





# September 2023 Completed Works

### At House Noise Treatment Works

# **Environmental Issues** (i.e.: not classified as Incidents as per MCoA)

There were four environmental issues in September:

- ACM was uncovered during a box out of the medium on Newcastle Road, east of Blue Gum Road.
- A small diesel spill on the fill during refuelling of a scraper.
- Sewage spill in zone 1 from a rising main that had accumulated in a sump.
- During sealing works on the Newcastle Road culvert, a small amount of denso primer D was used prior to laying the sealant tape when a small amount spilt and entered Dark Creek culvert. The area was closed off and a boom and absorbent pads used to contain the spill. No primer escaped further past the Dark Creek culvert works area.

All spills were dealt with using the appropriate mitigation and clean up methods with no further action required.

### Monitoring

- Monthly noise monitoring as per NVMP did not exceed NML's.
- Water quality was undertaken during the month, the lab results are not yet available however field measurements did not indicate any issues attributable to the project.
- Dust gauges were changed on September 29, the rolling averages are all below the criteria of 4, noting that there is not sufficient data for the rolling average to be reported accurately.



# **Closing Remarks**

Current construction works consist of earthworks, creek diversions, utility relocations, Dark Creek culvert works, traffic diversions, pilling and pouring bridge footings, installation of permanent drainage and continual updating and installation of ERSED controls and requirements.

The monthly inspections were carried out as required with only minor matters being noted. The management of dust appears to be well handled with a number of water carts now operational and the construction team trialling the use of a haul road designed soil binder; the results of which will be very useful moving forward. Continual vigilance on dust management is however required. Residential property noise treatment works are also ongoing.

The site environmental team appear to work collaboratively as a team to manage the environmental risks of the project and work diligently to close out matters raised at the inspections.
