LITTLE EVELEIGH STREET OPERATION

From Friday 10 May, the Little Eveleigh shared zone will operate in its final state for motor vehicles, cyclists and pedestrians.

This means all previous traffic arrangements that were in place before, or while the shared zone was completed, will be replaced by the new, permanent arrangements.

KEY CHANGES AND WHAT THEY MEAN FOR YOU:

Direction of vehicle traffic:

All motor vehicles must enter Little Eveleigh Street from Ivy Street / Wilson Street shared zone, and exit at Lawson Street.

(Pedestrians and cyclists can travel in either direction in the shared zone).

Vehicle speed:

The speed limit in the shared zone is 10km/hour for all vehicles, including cyclists.

Wilson Street traffic island:

A new traffic island prevents motor vehicles travelling eastbound from Wilson Street into the shared zone.

(City of Sydney Council is investigating future upgrades to the Wilson Street shared zone, such as paving and landscaping, to improve the streetscape, while retaining features like the large tree at the corner of lvy Lane).

Wilson Street shared zone:

The Wilson Street shared zone is one way for motor vehicles. Entry is from Ivy Street and vehicles can exit into the car park, Ivy Lane or the Little Eveleigh Street shared zone.

Ivy Lane

Ivy Lane is one way. Motorists must enter Ivy Lane from Wilson Street or the car park, and exit at Lawson Street.

On-street parking:

Signposted parking restrictions are already in place in the shared zone and on nearby roads.

Motorists should follow the signposted parking conditions - as parking restrictions are enforceable and fines will apply.

LITTLE EVELEIGH STREET CAR PARK

From Friday 10 May, the Little Eveleigh Street car park will be open and available to local permit holders.

Non-permit holders are restricted to one hour.

Motorists should enter the car park from Ivy / Wilson streets and exit via Ivy Lane.


Reinstating the Lawson Street pedestrian crossing:

The crossing will be reinstated when additional street lights are installed and the crossing can be adequately illuminated at night.

Nearby residents will be notified before work to install the lights and crossing takes place.
