# Have your say: Proposed upgrades on Reservoir Road

### **Reservoir Road Upgrade**

February 2024





Transport for NSW acknowledges the Dharug people as the Traditional Custodians of the lands on which we work and pay respect to Elders past and present.

Transport is proposing to make changes to a pedestrian crossing on Reservoir Road, Blacktown between Matthew Crescent and Theresa Street and parking on the northbound lane between Matthew Crescent and Cooper Street.

An investigation was carried out from the crash history on Reservoir Road and safety concerns that vehicles were not giving way at the pedestrian crossing between Matthew Crescent and Theresa Street. The investigation found that there is an opportunity to improve pedestrian safety and reduce congestion along Reservoir Road, Blacktown.

#### **Proposed changes**

Transport is proposing to make improvements to the existing pedestrian crossing on Reservoir Road between Matthew Crescent and Theresa Street.

The proposal includes introducing 95 metres of full time 'No Stopping' on the northbound lane along Reservoir Road between Matthew Crescent and Cooper Street.

The proposed 'No Stopping' results in the loss of around 15 parking spaces.

#### **Project benefits**



- upgrades to the pedestrian crossing improves pedestrian safety when crossing the road, especially for vulnerable people
- 'No Stopping' zone improves safety for road users and residents by

reducing vehicle weaving movements due to parked vehicles on the road



- a full time 'No Stopping' zone results in easier access and sight lines for residents entering and exiting their driveways
- 'No Stopping' improves traffic flow and reduces congestion by using all lanes available resulting in quicker travel times

# What is a 'No Stopping' sign?

'No Stopping' means you must not stop at any point on the road or kerb in the direction of the arrow, unless in an emergency. Restrictions always apply.


#### What's next?
