



Project Update

Central Coast Highway and Tumbi Road intersection upgrade

June 2024



Transport for NSW acknowledges the Darkinjung people as the Traditional Custodians of the lands on which we work and pays respect to Elders past and present.

The Australian Government and NSW Government are investing \$65.5 million to upgrade the Central Coast Highway and Tumbi Road intersection.

As part of plans to improve traffic flow and safety on the Central Coast Highway between Wamberal and Bateau Bay, the NSW Government has prioritised the most congested intersection at Central Coast Highway and Tumbi Road.

What have we been doing?

Early work to prepare for the intersection upgrade was carried out last year and has been completed.

These works included vegetation clearing, surveying, minor earthworks, geotechnical testing, installation of utilities pits, conduits and cables, as well as demolition of Transport-owned property.

Proposed facility on Tumbi Road

A location has been proposed for a temporary ancillary facility on council owned land at 6B Longview Close, Wamberal, behind the Rural Fire Service.

The facility may be used for, but not limited to the following activities:

- Site office
- Worker amenities

- Equipment and materials storage
- Temporary stockpiling of excavated or imported material
- Holding and treatment facilities for water from dewatering activities
- Temporary storage of waste awaiting classification
- Chemical and fuel storage
- Storage of construction plant and parking for light and heavy vehicles
- Acid Sulfate Soil (ASS) treatment pads.

The project team will notify nearby residents and consult directly with them prior to finalising the site office details. We are proposing to temporarily fence and screen the site and we may be able to modify the internal site layout to reduce visual and noise impacts where possible.

Further details will be available on the project website in the Addendum Review of Environmental (AREF) factors, scheduled for publication in the coming months.

Upcoming survey work

Geotechnical and survey investigations will be occurring to assist with planning for the Tumbi Road intersection upgrade.

When and where we'll be working

Survey work and contamination assessment will be undertaken at 6B Longview Close, Wamberal, 869 Central Coast Highway and the western corner of Tumbi Road and Central Coast Highway.

We'll be working from **Tuesday 25 June for two weeks, weather permitting**. Working hours are **7am to 6pm, Monday to Friday's**.

We will notify nearby residents and businesses in advance if we need to work outside these times.

What will this mean for you?

You may notice vehicles and machinery accessing the sites however no noise impacts are expected.

Managing our impacts

We will make every effort to minimise these impacts by:

- turning off machinery and vehicles when not in use
- planning activities close to residents within standard construction hours

What's next?

For the next stage of the project, Transport for

NSW has invited Expressions of Interest (EOI) from pre-qualified contractors to build the upgrade of the highway with Tumbi Road. EOI closes Tuesday 11 June at 2.30pm.

Construction for the main works on the Tumbi Road intersection upgrade is subject to approval, therefore while timing is not confirmed it is expected to start in early 2025.

The results of onsite investigations and community consultation will be reviewed to confirm the final layout of the ancillary facility.

The project is expected take about two years to complete.

We will keep the community updated as work progresses.
