



Next steps: Wall Park Avenue proposed 'No Stopping' and bus zone changes

Wall Park Avenue 'No Stopping' and Bus Zones

April 2024



Transport for NSW acknowledges the Darug people as the Traditional Custodians of the lands on which we work and pay respect to Elders past and present.

We thank the community for the feedback received during the Have Your Say consultation held in May to July 2023. We listened to what you had to say.

In response to community concerns about on-street parking on the northern and southern side of Wall Park Avenue between Blacktown Road and Prospect Highway, Seven Hills, Transport for NSW (Transport) proposed changes to improve road safety, public transport efficiency, traffic flow and ease congestion to support reliable and safer journeys for all road users.

Installing a full-time 'No Stopping' zone restriction along Wall Park Avenue results in better sight lines for residents exiting their driveways and reduces vehicle weaving movements due to parked vehicles. Changing bus stops to bus zones helps increase driver awareness of bus stop locations, improving road safety.

How was consultation done?

On 24 May 2023, we distributed 2,700 community notifications to residents and businesses inviting feedback on a proposal to install full-time 'No Stopping' zone restrictions and change bus stop signage to bus zone signage.

The consultation period was from 24 May - 7 June 2023 with late submissions accepted until 28 July. Comments were invited via email, post, and phone.

What have we learned?

Transport received 42 submissions during the consultation period, all were from the general

community. There was support for the proposed 'No Stopping' zones and the change of bus stop signage to bus zone signage. Transport also received support from CDC bus operators who operate high frequency bus routes along Wall Park Avenue.

Submissions relate to:

- resident's safety when entering and reversing out of property
- parking for visitors and delivery services
- potential impact on property values
- support for the full-time 'No Stopping' zone and bus zones
- alternative options to the proposal

The feedback has helped us better understand how the local community uses Wall Park Avenue.

Transport has made the decision to progress the proposal with the following change:

- removal of the existing bus zone and bus stop on Wall Park Avenue near Blacktown Road and Burnie Street

Key benefits to the community:

- improve safety for all road users and residents
- reduce vehicle weaving due to parked vehicles on the road and limited sightlines in the vicinity of the vertical crest curve
- provide better sight lines for residents exiting and entering their driveways
- allow vehicles to overtake turning vehicles
- improve traffic capacity and traffic flow at signalised intersections and approaches resulting in quicker travel times



- the proposed measures will improve travel times for bus passengers and provide better bus stop safety and access
