

# Have your say: Proposed extension of 'No Stopping' zones on Woodstock Avenue

## Network Efficiency Program

March 2024



Transport for NSW acknowledges the Darug people as the Traditional Custodians of the lands on which we work and pay respect to Elders past and present.

Transport for NSW (Transport) is making improvements to enhance safety for residents and reduce congestion on Woodstock Avenue between Duke Street and the M7, Plumpton.

Woodstock Avenue has high traffic volumes and is commonly used by freight vehicles travelling between the M7 and commercial areas to the west. A review of parked vehicles found there is low usage of available parking spaces on Woodstock Avenue with sufficient space available in driveways or on side streets for vehicles to park.

### Proposed changes

Transport is proposing to extend 'No Stopping' zones on Woodstock Avenue between Duke Street and the M7.

Westbound 'No Stopping' zones will provide about one kilometre of additional lane space by removing about 88 potential car parking spaces.

Eastbound 'No Stopping' zones will also be formalised to improve safety.

### Project benefits

Extension of the 'No Stopping' zones will:



- improve safety for road users and residents by reducing vehicle weaving movements
- result in easier access and better sight lines for residents using their driveways and for pedestrians crossing the road



- improve traffic flow and reduce congestion by efficiently using all existing lanes, resulting in more reliable travel times.

### What is a 'No Stopping' zone?

A 'No Stopping' zone is identified by a red sign with a white arrow and writing on the roadside.

You must not stop at any point on the road, kerb or shoulder in a 'No Stopping' zone in the direction of the arrow, unless in an emergency.

'No Stopping' zone restrictions always apply unless shown on the sign.

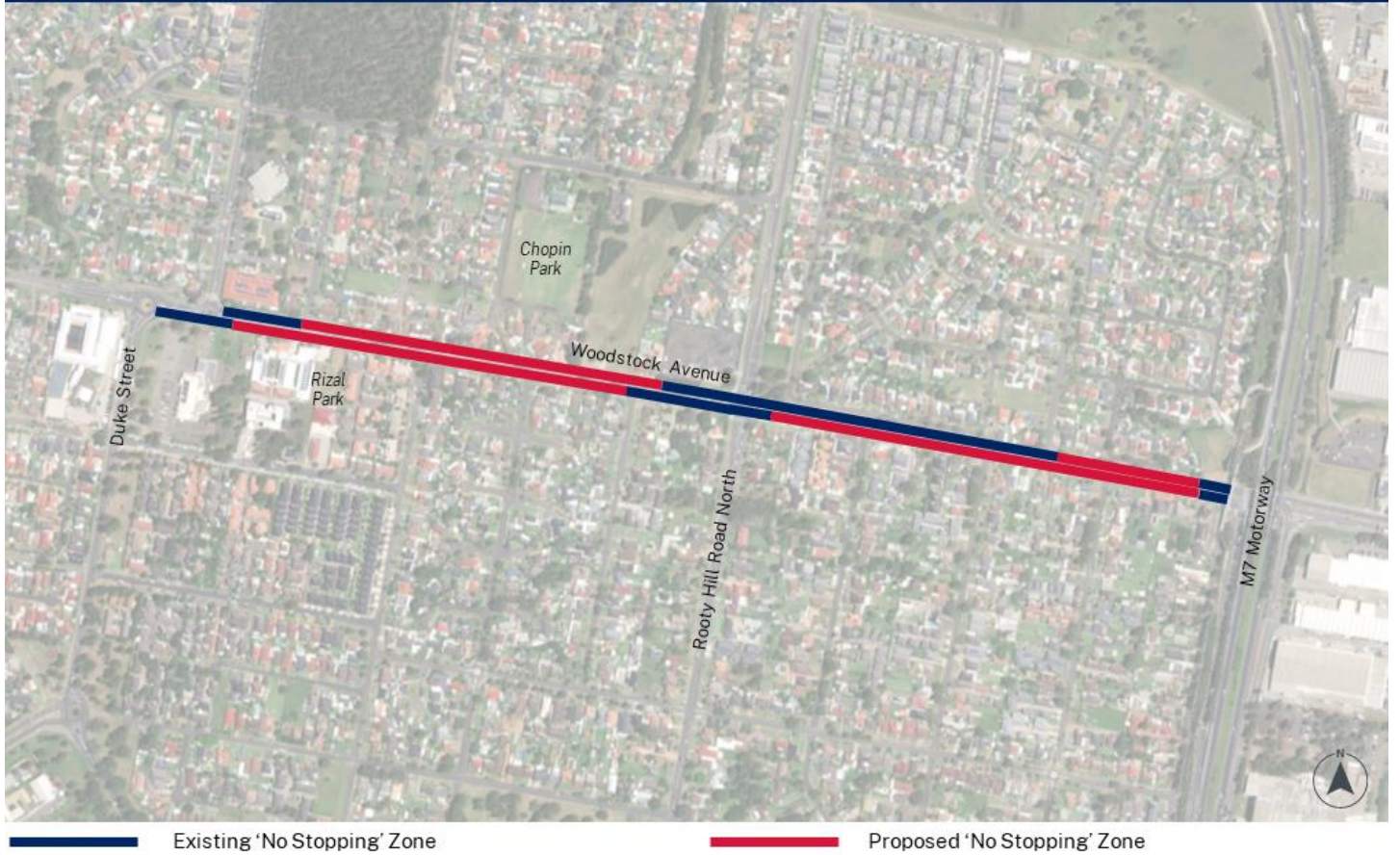
### What's next?
