# FAQ's Beverly Hills Parking changes

## How long will the parking changes be in place?

Parking changes will be in place until the Beverly Hills commuter car park is completed in late 2024. Transport for NSW (TfNSW) will keep the community informed of construction progress on the commuter car park, and Georges River Council will consult with the residents to determine the appropriate parking changes required, if any ongoing.

## How long can I use the timed parking spots?

The timed parking will be between one and three hours, depending on the location. Please see the map below for details for each street, showing timing.



## Why is the parking changing?

The council car park on Edgbaston Road was closed in March 2023 to construct the new Beverly Hills commuter car park under the TfNSW commuter car park program. In response to concerns raised by

the local business community, TfNSW and Georges River Council investigated alternative parking solutions to allow visitors to access parking near the Beverly Hills retail/ business town centre.

TfNSW completed an audit of parking in late 2023, to assess parking capacity on the streets surrounding the Beverly Hills business area. The study indicated that by converting some untimed parking to timed parking, additional parking spots close the business area would be made available.

Georges River Council are seeking feedback on these proposed changes.

### **Who will implement and enforce the parking changes if approved?**

Should the proposal go forward, Georges River Council will implement measures required to adjust the parking changes. These measures include signage as approved by Council. The parking restrictions will be enforced by Council Parking Officers.

### **Who will determine the parking changes?**

Georges River Council, who is the authority for on-street parking changes on local roads, will determine if the strategy will be implemented, following community feedback. Parking changes will go through Council's local traffic committee for assessment. If approved by the Committee, these would then be submitted to a Council meeting for consideration.

### **What signage will be included in the proposal?**

Signage will be included in the proposal to indicate timed parking.

### **Can a resident parking scheme be implemented in our streets?**

During the proposed temporary changes to the parking restrictions, Resident Parking Permits will not be issued and will be considered following the completion of the BHCCP.

### **Can I have a Disabled Accessible parking in front of my property?**

This parking is considered for properties whose permanent resident lives with a disability. Georges River Council can only implement accessible parking in streets that are wide enough to accommodate accessibility vehicle needs.

To be considered, you must submit a copy of your valid driver's licence and mobility parking permit via email to [mail@georgesriver.nsw.gov.au](mailto:mail@georgesriver.nsw.gov.au). Council Officers will assess your application and provide a response.
