

Crowdy Head Boat Harbour

Submissions Report released and planning approval received.

The NSW Government is delivering major improvements to maritime infrastructure and facilities state-wide, to help the boating and wider community safely access, use and navigate our inland and coastal waters.

Submissions Report now available and planning approval received.

In June 2022, Transport for NSW (Transport) invited the community and stakeholders to have their say on the Review of Environmental Factors (REF). Thank you to everyone who provided feedback during this time.

Planning approval has been received and we are proceeding with plans to upgrade Crowdy Head Boat Harbour.


About the upgrade:

The project includes the demolition and replacement of Jetty 1, and includes:

- new heavy duty floating pontoons
- water and electricity to each berth
- 18 berths of various sizes
- one temporary or short term berth
- demolition of Jetty 2
- dredging of the harbour

Benefits of the upgrade:

- improved accessibility and safety for vessels using Crowdy Head Boat Harbour
- increased safety for users of the harbour by upgrading infrastructure to meet modern design standards and requirements
- improved community access and use of the harbour



Key feedback topics

A total of 47 submissions were received in response to the display of the REF.

The key feedback topics raised during public display included:

- the need for a fishing platform to replace Jetty 2
- concerns for the floating pontoon in surging conditions
- requests for the dredging area to be extended
- community access to Jetty 1

Design update

In response to submissions received, Transport has made the following changes to the design:

- increased dredging area to take into consideration the area near the boat ramp
- a design for a replacement fishing platform has been developed and we are exploring additional funding options
- updated structural details following detailed engineering study.

Next steps

Pending further approvals and confirmation of funding, construction is expected to begin in mid to late 2024 and take about 10 months to complete (conditions permitting).

We will notify the community before starting work.
