Item 2: Policy and Legislation update

- Amendments to the Marine Pollution Regulation have been approved by ExCo and the new regulation is expected to be remade later this month.

Item 3: Education Update

LB

- Youth Waterway Boating Campaign: Educate on key safety messaging around lifejacket wear, PWCs, safe speed, and the associated risks when engaging in boating activities.
- Lifejacket Online Learning Initiative: Launched public facing interactive mini-lessons to boost safety on our waterways by increasing education about lifejacket and safety equipment. Link here: Lifejackets and safety equipment Overview (nsw.gov.au)
- Coastal Bar Crossing Safety Campaign: Messaging focused on crossing a bar safely, directing people to our resources for further information around coastal bar dangers, checking conditions, preparing your vessel, checking safety equipment and crossing safely.

Item 4: Maritime Infrastructure Delivery Office

Kamay Ferry Wharves (Botany Bay) – Construction of multi-user wharves at La Perouse and Kurnell to accommodate passenger ferries and other vessels. Due for completion late 2024.

- Coffs Harbour Boat Ramp New boat ramp, car park and amenities. Open to the public December 2024.
- **Coffs Harbour Vessel Refuelling Facility** On water fuel facility to service agency, commercial and public vessels. Due for completion March 2024.
- Crowdy Head Jetty Replacement Project Replacement of dilapidated jetties with new and dredging of harbour and boat ramp area. Environmental approvals and tender design completed. Awaiting final approval and funding.

- Snug Cove Maritime Precinct Application for Federal Grant to construct a 79 berth marina, administration building, ancillaries services which integrates with the tourism precinct. Draft REF proposal description chapter prepared and draft REF and Marine Ecology Assessment in progress.
- **Swansea Channel Dredging** Scheduled for completion 2024.

Item 6: Maintenance Service Repair Facilities

Submitted by Neil Patchett

- The Maritime Infrastructure Plan recognises the importance of vessel maintenance facilities to ensure the NSW recreational and commercial vessel fleet remains safe and operational.
- Since the plan was announced in December 2018 Transport has invested in a number of facilities which most recently include Coffs Harbour, Tea Gardens, Tweed Heads, Tuncurry.
- The Boating Now program has always been open to fund upgrades to these facilities and this is expected to continue in the future subject to the program being funded.
- It is recognised that any investment through the Boating Now program relys on a delivery partner seeking grant funding.

Item 7: Vessel Waste Collection

Submitted by Neil Patchett

- The Maritime Infrastructure Plan (MIP) also recognises the importance of sewage pumpouts to minimise environmental impacts of recreational and commercial vessels with a toilet on board. Pump outs were also identified as a priority infrastructure outcome at a number of locations.
- While the Boating Now program is available to fund sewage pump-out projects, it is
 recognised that only a small number of these facilities have been constructed since Boating
 Now and the MIP were announced. As part of the review of the MaritimeIP consideration
 may be given to whether an alternative approach is required to support delivery of sewage

pump-outs across NSW subject to funding being provided for these programs.
