


# Chester Hill Station Upgrade Planning approval

# Safe Accessible Transport program

January 2025





Transport for NSW acknowledges the Cobrogal and Wangal people of the Dharug Nation as the Traditional Custodians of the lands on which we work and pays respect to Elders past and present.

Transport for NSW (Transport) is upgrading Chester Hill Station to improve accessibility, amenity and safety.

In September 2024, Transport publicly displayed the Review of Environmental Factors (REF) for Chester Hill Station Upgrade, being delivered as part of the Safe Accessible program.

We invited community and stakeholder feedback on plans to provide an accessible station with improved amenity and safety for customers.

The project includes a new lift, stairs, and elevated walkway connecting Chester Hill Road to the station platforms, as well as other improvements such as a new family accessible toilet, kiss and ride, as well as improved CCTV and lighting.

Following public display of the REF and consultation, the proposed upgrade of Chester Hill Station is now approved to proceed.

#### What we heard

Thank you for taking the time to provide feedback, we received a total of 34 submissions.

Key feedback included:

- Overall community support for the upgrade.
- Suggestions for local traffic changes including speed humps and other traffic calming to improve congestion and safety.

- Suggestions to review the location of the taxi rank, kiss and ride and accessible parking to improve functionality.
- Requests to revise metered/timed parking in the area, retain existing parking allocation as well as increasing accessible and kiss and ride parking spaces.
- Need for improved train services and better interconnectivity of bus and train services.
- Suggestions for signage to be in Braille for vision impaired passengers.
- Suggestions to incorporate local and historical design elements.
- Requests for solar powered charging spot at bus stops.

Feedback received has been considered by the Project Team to help inform the design for the upgrade. Transport's response to feedback received is now available online in the Determination Report.

Feedback that related to items outside the scope of the proposal have been provided to the appropriate agency for consideration.



#### What's next?

Transport has recently awarded a contract for the design and construction of the station upgrade.and will continue to keep the community and other stakeholders up to date as we work towards site establishment and construction to commence in the coming months.
