

Transport for NSW acknowledges the Gadigal and Bidjigal people as the Traditional Custodians of the lands on which we work and pays respect to Elders past and present.

Transport for NSW is improving pedestrian safety at the intersection of Rainbow Street and Avoca Street, Randwick. This work is being completed as part of the Federal Road Safety Program.

Work will start on **Sunday 30 March** and is planned to be complete by **Friday 13 June 2025.**

Federal Road Safety Program

The Federal Road Safety Program aims to improve safety and reduce crashes on NSW roads. The Pedestrian Protection Sub-Program aims to improve protection for vulnerable road users, particularly on urban footpaths, shared pathways, cycleways and road crossings.

Since 2020, the Australian and NSW governments have invested more than \$600 million into road safety projects across NSW as part of the Federal Road Safety Program.

What work are we doing?

We will be upgrading the traffic signals on **Avoca Street** at its intersection with **Rainbow Street**, **Randwick**. Please refer to the location map overleaf.

Our work will include:

- introducing a new signalised pedestrian crossing on the southern side of the intersection
- installing new lantern arrows to hold vehicles when pedestrians are crossing

- reconstructing sections of the concrete median and footpath
- renewal of traffic signals cabling
- cutting into the road surface to install traffic signal loops for monitoring traffic flow
- restoring the road surface and line marking.

When and where we'll be working

We will be onsite for up to 15 nights between Sunday 30 March and Friday 13 June 2025, weather and site conditions permitting.

Our work hours will be between **8pm** and **5am** from **Sunday** to **Thursday**.

We will not work on Fridays, Saturdays, or public holidays.

Our work needs to be carried out at night to minimise traffic disruption and reduce safety risks to workers and motorists.

If you have any concerns about our work schedule or activities, please contact our delivery partner, ConnectSydney, as detailed in the contact us box overleaf.

What will this mean for you?

You may notice:

- workers and vehicles
- traffic controllers and signage
- lane closures and reduced speed limits
- pedestrian detours with traffic controllers on site to guide you
- noise from machinery and equipment.



Managing our impacts

This includes:

- · reducing our noise as much as possible
- · turning off equipment when not in use
- positioning equipment away from homes and businesses
- completing noisier tasks by midnight.

Temporary traffic changes 8pm-5am

- You may notice temporary traffic changes during work hours to ensure the work zone is safe.
- We will ensure access to properties in and near the work zone are maintained.
- Please keep to speed limits and follow the direction of traffic controllers and signs.
