



## Safety improvement work at the intersection of Langston Place and Cambridge, Pembroke and Oxford Streets, Epping from Tuesday 10 June 2025

### Community Notification

June 2025



Transport for NSW acknowledges the Wallumedegal people of the Dharug Nation as the Traditional Custodians of the lands on which we work and pays respect to Elders past and present.

Transport for NSW will improve pedestrian safety at the intersection of Langston Place and Cambridge, Pembroke and Oxford Streets, Epping. This work is being completed as part of the Road Safety Program.

Work is expected to start on **Tuesday 10 June** and be completed on **Wednesday 11 June 2025**. This work is being coordinated with City of Parramatta Council works also being carried out at this location.

### Road Safety Program

The Road Safety Program, launched in early 2024, aims to improve safety and reduce crashes on NSW roads. The Australian and NSW governments are investing \$518 million into road safety projects across NSW as part of this program.

### What work are we doing?

Work activities will include:

- installing new arrow lanterns on the existing traffic light poles to allow pedestrians to more safely cross the intersection while holding motorists on red arrows
- repainting road markings.

### When will we be working?

We will be on site for up to **two night shifts**, one night to carry out the traffic control changes and one night to carry out the line marking work.

We plan to complete the work between **Tuesday 10 June** and **Wednesday 11 June**. If we cannot complete the work during this time the work will be completed by **Friday 27 June 2025**, weather permitting.

We will work between **Sunday** and **Thursday, 8pm** and **5am**, the next day.

We will not work on Friday and Saturday nights.

### What will this mean for you and how will we manage it?

Our work needs to be carried out at night to minimise disruption to traffic and reduce safety risks to our workers, pedestrians, and motorists.

It may be noisy at times, but we will do everything we can to minimise our impacts by:

- turning off equipment and vehicles when not in use
- completing noisier tasks by midnight
- area when carrying out noisy activities
- using quieter equipment where possible.

### Traffic changes

There will be temporary traffic changes to make sure the work zone is safe. This will include lane closures and a reduced speed limit of 40km/h.

Temporary traffic lights will also be used while we install the new arrow lanterns.

Access to the pedestrian crossings and footpaths will be maintained under the guidance of traffic controllers. Please keep to speed limits and follow the direction of traffic controllers and signs.

Transport for NSW thanks the community for their patience while we complete this important safety improvement work.
