

Transport Access Program Canley Vale Station Upgrade Planning approval



The NSW Government is improving accessibility at Canley Vale Station

Planning approval follows the public display of the project's Review of Environmental Factors, which was held from 29 April - 13 May 2020. The project team received 28 submissions during the public display period.

Each submission was considered by the project team and responded to in a Determination Report.

Transport for NSW would like to thank the community for their submissions.

The upgrade will include:

- two new lifts from the existing footbridge to the station platforms
- new accessible parking space and kiss and ride on First Avenue
- one family accessible toilet and two ambulant toilets
- regrading sections of the platforms
- improvements to lighting, wayfinding and CCTV.

Feedback from the community

The key themes that emerged during the public display period included:

- general support for the station becoming accessible
- requests for the upgrade to progress as quickly as possible
- request for better lighting on the streets surrounding the station.

Design and site preparation work will occur over the coming months, with major construction expected to start in late 2020.
