Sutherland to Cronulla

COMMUNITY NOTIFICATION

Transport for NSW (TfNSW) is rolling out new technology to upgrade Sydney's rail network and introducing modern signalling as part of the Digital Systems Program.

The Program will replace current signalling and train control technology with modern, internationally proven, intelligent systems. It will help improve reliability and increase capacity on Sydney's railways once implemented widely across the network.

Upcoming works - Sutherland

Various work will continue in August along the Sutherland to Cronulla rail corridor during standard hours – **Monday to Friday 7am to 6pm** and **Saturday 8am to 1pm**.

As overall construction work along the corridor is nearing completion in coming months, site infrastructure within the existing Sydney Trains compound at East Parade, Sutherland will start demobilising from 22 August to 7 September (see work area on diagram overleaf). This work will also be completed during standard construction hours from **Monday to Friday between 7am and 6pm**.

Work will involve:

- Decommissioning of construction site compound, site containers and generator with the help of a crane truck.
- Temporary pedestrian changes at times along East Parade, with traffic controllers guiding pedestrians away from the work site.
- Temporary blockage of some parking lots at East Parade in front of site compound for truck and vehicles entry.
- Removal of lighting and other minor works.

Traffic control and signage will be in place for the safety of workers and the community. Access to buildings and driveways will be maintained at all times.

What you may notice

TfNSW is committed to minimising noise impacts on the community. Delivery of machinery, equipment and materials with trucks movement may also occur outside of standard work hours to ensure the safety of the community and our workers.

We switch off equipment when it is not being used, place equipment as far away from properties as possible and monitor our work activities to make sure noise levels are being managed effectively.
