

Power Supply Upgrade

DC Feeder Upgrade Project – Gordon

Community Notification – August 2022

Transport for NSW is making improvements to electrical infrastructure to meet expected power requirements for Sydney's future rail network and new fleet of air-conditioned trains. As part of this, Transport for NSW is carrying out power supply upgrade work through our DC Feeder Upgrade Project.

Project overview

The DC Feeder Upgrade Project will improve power delivery to the railway and involves the replacement of electrical cables and overhead wiring infrastructure across a number of sites in the rail network, including at Gordon.

Weekday and Weekend work

Construction work will take place from **7am to 6pm from Monday 1 August to Friday 5 August 2022 and 6am to 6pm on Saturday 6 August and Sunday 7 August 2022**. Please see work location map overleaf for details on the work area.

The work in your area will not be continuous. Every effort will be made to keep the construction noise to a minimum and reduce impacts to the community whenever possible.

Work activities include structure strengthening works within the rail corridor. Workers will access the corridor from the Werona Avenue carpark. Equipment will include a generator, elevated work platform, hand drill, rattle gun and various handheld power tools.

What you may notice

Transport for NSW is committed to minimising noise impacts on the community. To ensure our works are safely carried out, we will require the temporary removal of up to 6 parking spaces within the Werona Avenue carpark.

We switch off equipment when it is not being used, place equipment as far away from properties as possible and monitor our work activities to make sure noise levels are being managed effectively.
